- 1. Verify Quorum/Roll Call: Confirmed.
- 2. Call to Order: Chairman Lewis Bear called the meeting to order at 10:03 am.
- 3. Public Notice: This meeting was publicly noticed on 5/11/2021.
- **4. Public Comment:** Public comment was requested. There was none. At the end of the meeting, Brian Wyer shared that there is an upcoming event. He will share the information with Melissa Stoker for distribution to the board.

5. Action Items:

- Approval of April 27th, 2021 Meeting Minutes: Steven Barry moved to approve.
 Dave Hoxeng seconded.
 Passed unanimously.
- b. Approval of April 2021 Financials:

Scott Luth provided an update on the monthly financials. He did identify an increase in Tech Park Security for graduations and Pensacon. We are also expecting an increased expense for some landscaping issues on the back side of the property.

Steven Barry moved to approve.

Dave Hoxeng seconded.

Passed unanimously.

- c. Clorissti Shoemo Resignation Notification: The City of Pensacola is accepting applications for her replacement through June 4th, 2021. The item is slated to be on the City Council agenda for the June 17th, 2021 meeting. Lewis Bear shared that he would like a letter drafted to express our thanks for her role on the board. Steven Barry moved to approve. Dave Hoxeng seconded.
 - Passed unanimously.

6. Discussion Items

- a. Tech Park Update: Lewis Bear provided an update on several prospects that have expressed interests in the property. There is one offer that is still active from Mr. Bob Montgomery. There have been a number of cyber related companies that have had interest both in and out of town. We are moving forward to develop our options. Since the last board meeting, we have met with two separate companies who are interested in picking up from where Space Florida left off as an anchor tenant. Scott should have more information by the next PEDC meeting. Steven Barry asked who we would be negotiating with. Both private parties are currently operating independently but are working with Space Florida. If we follow the same format as last time, PEDC would approve a ground lease to Space Florida. Dave Hoxeng asked if we would have the same advantages if PEDC built the building. Lewis Bear stated that PEDC wouldn't receive the same tax break as the state of Florida. Dave Hoxeng also asked if a SKIFF would be included in this design, which Scott confirmed would be for lease out. In addition, Scott Luth and Richard Sherrill have met with EDA. Richard Sherrill shared details of their conversation. The board discussed various scenarios.
- **b.** Economic Development Update
 - 1. Business Development: Danita Andrews shared that the FTZ Board has confirmed receipt of our application. She has received notice to access the federal register to track progress. Scott Luth shared that we will continue to keep the board updated. Danita Andrews also shared that we have a new expansion opportunity to add 120,000 sq ft of space near the interstate with 10 additional jobs. We are also working with a potential tenant for CO:LAB Pensacola where they would soft land here and then grow. We are also working with a few people interested in the Midtown Commerce Park. Scott Luth shared that we are in Phase II with Central Commerce Park. We are awaiting feedback on whether they will progress. Steven Barry asked us to reach out to two specific contacts he will be sharing with us.
 - **2.** Workforce: Scott Luth shared that we are working with Century to submit an application for State DEO funds available to support rural cities.
 - **3.** CO:LAB Pensacola: We are excited to be back! We are working to finish up our list of urgent items to get tenants back in. Lewis Bear shared that the building and outdoor area really looked good. Patrick Rooney shared that we do have potential interested tenants both returning and out of the area. We are projecting at 47% occupancy between returning clients and the pipeline developing.
 - 4. Marketing: Sena Maddison shared that we had 130,000 impressions which is 36 times the national average. We are getting word that May is looking even better.

7. Other Business:

- **a.** Legislative Updates:
- Bluffs Update: Scott Luth shared that we are currently in the budget for \$2.5M for the roundabout project waiting to see what happens with the Governor's vetoes.
- Scott is looking to coordinate a meeting between the City and County to discuss prioritizing top projects with money coming down from the state and federal government. His goal is to get that meeting scheduled in the next 90 days to ensure we are maximizing the dollars.

8. **Adjourn:** Lewis Bear adjourned the meeting at 11:04 am.

Overview of the CareerSource Escarosa Region Not Seasonally Adjusted July 16, 2021

- The unemployment rate in the CareerSource Escarosa region (Escambia and Santa Rosa counties) was 5.2 percent in June 2021. This rate was 3.0 percentage points lower than the region's year ago rate of 8.2 percent. The region's June 2021 unemployment rate was 0.5 percentage point lower than the state rate of 5.7 percent. The labor force was 241,381, up 17,540 (+7.8) over the year. There were 12,539 unemployed residents in the region.
- Santa Rosa County had the lowest unemployment rate (4.5 percent) in the CareerSource Escarosa region followed by Escambia County (5.6 percent).
- In June 2021 nonagricultural employment in the Pensacola-Ferry Pass-Brent MSA was 184,600, an increase of 5,100 jobs (+2.8 percent) over the year.
- The professional and business services (+5.8 percent); mining, logging, and construction (+4.2 percent); education and health services (+3.3 percent); and government (+1.1 percent) industries grew faster in the metro area than statewide over the year.
- The Pensacola-Ferry Pass-Brent MSA was tied for the third highest annual job growth compared to all the metro areas in the state in government (+300 jobs) in June 2021.
- The industries gaining in jobs over the year were professional and business services (+1,400 jobs); education and health services (+1,000 jobs); leisure and hospitality (+1,000 jobs); mining, logging, and construction (+500 jobs); trade, transportation, and utilities (+500 jobs); government (+300 jobs); financial activities (+200 jobs); and other services (+200 jobs).
- The manufacturing and information industries were unchanged over the year.

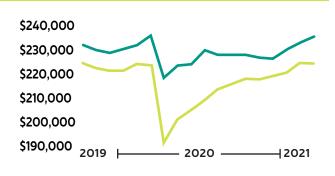
