UWF is one of the few colleges and universities recognized by SPLC as a campus that supports and implements social justice initiatives.

<u>Multicultural Competency</u> – Lead contributor to the creation and development of a five-module curriculum on multicultural competency for the Division of Student Affairs at the University of West Florida for training student affairs employees on multicultural competency and inclusion. Responsible for coordinating and facilitating the training.

- 2. Call to Order: Lewis Bear called the meeting to order at 10:00 am.
- **3. Public Notice:** This meeting was publicly noticed on 9/14/2021.
- **4. Public Comment:** Lewis Bear requested public comment. Brian Wyer publicly thanked all involved for the use and support of the Supplier Diversity Event with over 100 attendees. He presented Casey Campbell with a certificate of appreciation.

### 5. Action Items

a. Approval of July 27<sup>th</sup>, 2021 Meeting Minutes

Jeff Bergosh motioned to approve the minutes.

David Peaden seconded.

**b.** Approval of <u>August 2021</u> Financials

Steven Barry motioned to approve the financials.

c. Approval of FY 20-21 Budget Modification

### e. Bluffs/FDOT Funding Contracts/ Project RFP

Scott Luth shared that we received a formal contract from FDOT on \$2.5M in the last legislative session. Richard Sherrill has reviewed the contract. This contract is somewhat different in that we are moving forward with construction. Scott Luth is seeking approval of the resolution for FDOT as well as permission to move forward with the RFP to start the process of selecting an engineering firm. Once an engineering firm is select, FloridaWest staff will work with the engineering firm to select the construction contractor.

Lewis Bear requested a motion to approve the resolution and FDOT Contract.

Steven Barry motioned to approve.

Dave Hoxeng seconded.

Passed unanimously.

Lewis Bear requested a motion to proceed with the RFP for an engineering firm.

Ben Boutwell motioned to approve.

Dave Hoxeng seconded.

Passed unanimously.

Dave Hoxeng suggested PEDC RFP for an owner's rep. The board discussed this.

Dave Hoxeng motioned to immediately put out an RFP for an owner's rep to assist in assembling the document package. Steven Barry suggested we use this rep to also advise on if we can use the same engineering firm as the CEI.

Steven Barry seconded.

Passed unanimously.

Lewis Bear appointed Steven Barry, Dave Hoxeng, and David Peaden to serve on the RFP selection committee.

### f. Project Amber: Triumph Request

Steven Barry and Jeff Bergosh stated that the county will support the claw back for all three projects listed.

g. Project Pioneer: Triumph Request

### 6. Discussion Items

a. Review of FY 21-22 Draft Budget

Scott Luth presented the upcoming fiscal year draft budget. Dave Hoxeng asked about the \$28,000 loss from this year, which Scott Luth stated that we will cover with reserves. Lewis Bear shared that this is not uncommon but something to watch and manage.

- **b.** Economic Development Update
  - 1. Business Development: Scott Luth provided an update on this.
  - **2.** Workforce: Jeff Dyer provided an update. There have been several efforts. The employment data this month did not change month. September 30<sup>th</sup>, the

minimum wage increases to \$10.00 with a \$1 per year increase until 2026. This is a 73% increase over time. We are working with the Town of Century on a \$35,000 State Department of Economic Opportunity grant. PSC is also working with us on this effort. Scott Luth shared that Soar with Restore is another partnership effort along with a number of other agencies. Commissioner May is engaged, and we expect to see this on the October schedule. Steven Barry asked about Project Spruce. Scott Luth shared that we have received the draft lease document. They will finalize their version and then work with their attorney. Scott Luth shared that we expect to see that before the board of county commissioners in the next month or so.

- **3.** Marketing: The upcoming calendar is included in the board packet.
- **c.** Legislative/Funding Updates

Scott Luth shared that we are putting together our legislative requests. We may have a combined "Bluffs" request this year as a result of increased construction costs. We will also be requesting funds for the road extension to the south. We will have more information on this in the coming weeks.

**d.** Tech Park Update This was covered in the earlier discussion around Triumph requests.

- 7. Other Business: There was none.
- Adjourn: Lewis Bear adjourned the meeting at 11:25 am.

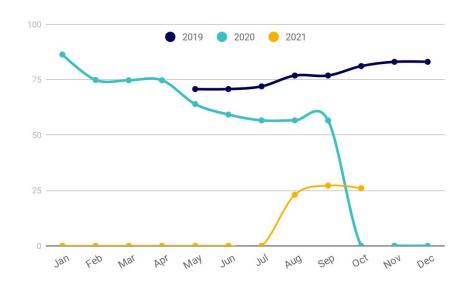

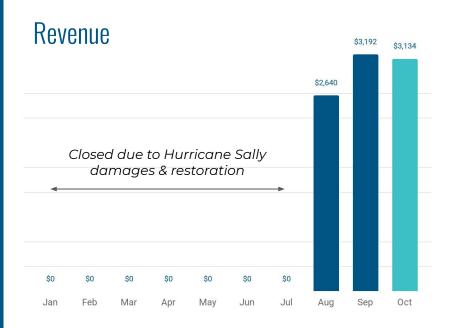

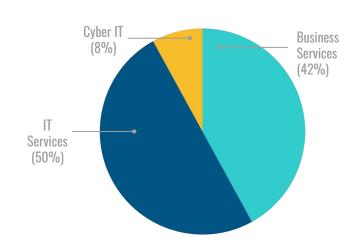

## Overview of the CareerSource Escarosa Region Not Seasonally Adjusted October 22, 2021

- The unemployment rate in the CareerSource Escarosa region (Escambia and Santa Rosa counties) was 3.9 percent in September 2021. This rate was 1.2 percentage points lower than the region's year ago rate of 5.1 percent. The region's September 2021 unemployment rate was 0.4 percentage point lower than the state rate of 4.3 percent. The labor force was 242,253, up 14,320 (+6.3 percent) over the year. There were 9,373 unemployed residents in the region.
- Santa Rosa County had the lowest unemployment rate (3.3 percent) in the CareerSource Escarosa region followed by Escambia County (4.2 percent).
- In September 2021 nonagricultural employment in the Pensacola-Ferry Pass-Brent MSA was 187,700, an increase of 6,100 jobs (+3.4 percent) over the year.
- The mining, logging, and construction (+10.3 percent); manufacturing (+4.4 percent); and government (+0.3 percent) industries grew faster in the metro area than statewide over the year.
- The Pensacola-Ferry Pass-Brent MSA had the third fastest annual job growth rate compared to all the metro areas in the state in mining, logging, and construction (+10.3 percent) in September 2021.
- The industries gaining in jobs over the year were leisure and hospitality (+2,000 jobs); mining, logging, and construction (+1,200 jobs); education and health services (+800 jobs); trade, transportation, and utilities (+700 jobs); financial activities (+700 jobs); manufacturing (+300 jobs); professional and business services (+200 jobs); other services (+100 jobs); and government (+100 jobs).
- The information industry was unchanged over the year.

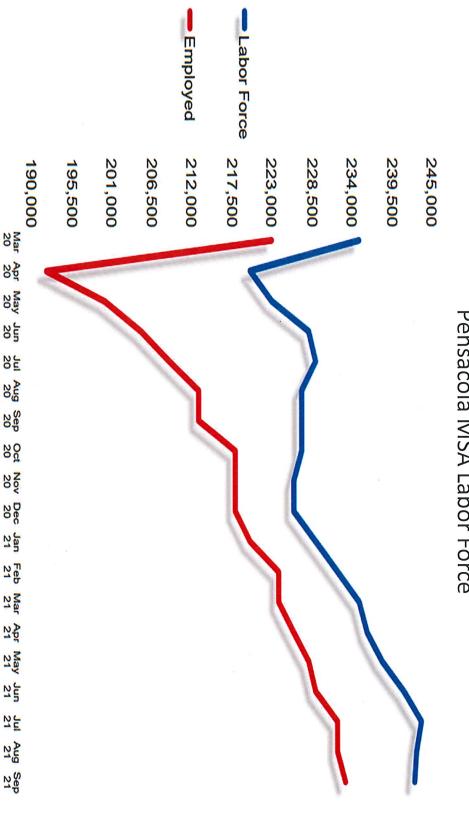
